# ***SUMMARY of CHANGE***

Camp Gruber Regulation 200–3  
Natural Resources—Land, Forest and Wildlife Management

This Training Site regulation--

- Sets forth responsibilities, policies, and procedures to wisely use and scientifically manage renewable natural resources existing on Camp Gruber lands consistent with the local military mission, national security, and current State and Federal laws pertaining to renewable resources and the quality of the environment.
- Replaces the previous Camp Gruber Regulation 200-3 dated 1 January 2003.
- Condenses regulation by changing format and consolidates similar chapters.
- Provides current point of contact information in the text and on the back cover.
- Removes language indicating the State Environmental Program Manager will fund wildlife activities and programs formerly contained in section 1-4. Current National Guard Bureau guidelines prevent use of Environmental funding for such programs.
- Deletes information in section 1-5 pertaining to the automated phone access notification system. The system is no longer operational.
- Defines “antiquities” in section 1-9 to include relics and arrowheads.
- Modifies language in section 2-3 referring to scheduled UXO briefings to inform hunters of new option of attending a scheduled briefing to obtain an access permits.
- Clarifies language in section 2-7 regarding activities in designated seasons and adds language to regulate activities in the restricted areas.
- Updates section 2-7 to be consistent with State wildlife regulation changes occurring since previous version. Specifically, the addition of the youth turkey hunt, youth antlerless deer gun hunt, and antlerless muzzleloader season.
- Adds language to clarify consistency of Camp Gruber bag limits in section 2-8 with those established by ODWC for the Cherokee Public Hunting Area.
- Adds provision in section 2-9 to address possession of a concealed weapon while afield in accordance with the Oklahoma Self Defense Act.
- Updates section 2-10 to be consistent with language in Oklahoma Department of Wildlife Conservation (ODWC) Hunting Guide.
- Updates section 2-11 to include information related to unauthorized off road travel and expands section to include utility vehicles.
- Clarifies language in section 3-5 regarding prohibition of hunting and fishing in the restricted areas.
- Adds provision in section 3-9 to address possession of a concealed weapon while afield in accordance with the Oklahoma Self Defense Act.
- Deletes check-in and check-out procedures previously presented in Chapter 2 due to lack of application to Camp Gruber.
- Provides an updated version of the Hunting Area Map (pg 7).

**History.** Camp Gruber is a 33,027 acre Army National Guard Facility near the town of Braggs, Oklahoma. Training Army National Guard and Active duty soldiers is the primary mission, though natural resources are actively managed in accordance with the Sikes Act. Prior to January 1, 2003, fish and wildlife management was handled by the Oklahoma Department of Wildlife Conservation (ODWC). The Oklahoma Army National Guard has since assumed these responsibilities as part of a mutual agreement between the two parties.

**Summary.** This regulation prescribes current policies, procedures, and standards for conservation, management, and restoration of land and renewable natural resources therein consistent with and in support of the military mission.

**Applicability.** All Camp Gruber users, including civilian personnel, military personnel, employees of the Oklahoma Army National Guard, and Oklahoma Military Department.

**Proponent and exception to authority.** The proponent of this regulation is the Camp Gruber Environmental Office, under direction of the Chief Facility Engineer and Training Site Manager. Possibilities for exception are governed by applicable State and Federal laws, Army Regulation, local policy and procedure. All requests shall be reviewed on an individual basis.

**Suggested improvements.** All users are invited to send comments or suggestions to Camp Gruber Maneuver Training Center, OKCG-FE-ENV, PO Box 29, Braggs, OK 74423.

**Distribution.** Distribution of this publication is intended for all users of Camp Gruber for the purposes of hunting, fishing, and all other types of outdoor recreation.

## **Chapter 1 INTRODUCTION**

### **1-1. Purpose**

This regulation establishes policies and procedures governing use of the Camp Gruber Maneuver Training Center (CGMTC) for outdoor recreational activities, hunting, fishing, trapping, and other general public access.

### **1-2. Mission**

a. The primary mission of CGMTC is to conduct military training and related military activities requiring the use of land controlled by the Commander of CGMTC. Mission requirements take priority over all other activities.

b. The opportunity to hunt and fish is a privilege extended by the CGMTC Commander and is subject to area availability, as determined by the Commander or designated representative.

### **1-3. Authority**

a. The CGMTC Commander retains sole authority in accepting and terminating individuals participating in the programs or canceling the programs based on mission requirements. The Commander, in accordance with appropriate Department of Army regulations and Federal or state laws, manages all authorized activities on CGMTC.

b. Restrictions are established to promote safety, security, protection of property, enhancement and conservation of wildlife resources, while allowing mission accomplishment.

c. The authority to hunt, trap, or fish requires possession of a valid state license and a CGMTC access permit.

d. Hunting, fishing, and trapping activities on the CGMTC will be by access permit only and will be governed by this regulation.

e. Oklahoma Department of Wildlife Conservation (ODWC) Game Warden(s) has legal jurisdiction on CGMTC.

f. Any person who violates applicable federal or state laws or regulations is subject to apprehension and/or detention by Military Police, Camp Gruber Security Force, and ODWC game warden(s).

g. Violations may result in suspension/revocation of access privileges to CGMTC.

### **1-4. Supervision**

a. The CGMTC Commander, in cooperation with ODWC, manages the fish and wildlife programs and develops plans for continued enhancement of fish and wildlife resources on the CGMTC. Various agencies support fish and wildlife research and habitat development on CGMTC.

b. The CGMTC Wildlife Manager will exercise administrative supervision of the hunting and fishing programs and will serve as primary point of contact (POC) for all related activities.

c. All hunting and fishing on CGMTC, to include seasons, bag limits, creel limits and size limits will be in accordance with state and federal laws and Army regulations. Nothing in this regulation will be interpreted to permit acts contrary to either state or Federal law. Violation of any CGMTC regulations will be considered an unauthorized activity that may result in loss of hunting and fishing privileges on CGMTC, prosecution by federal or state authorities, or both.

d. The Chief of Operations and Training will release training areas for public use. This information will be provided no later than 48 hours in advance of each authorized day.

(1) Availability schedule may change at any time due emergency.

(2) Areas open for public use will be provided in accordance with the Camp Gruber Notification System.

e. The CGMTC Provost Marshal's Office (PMO) and OMD security will enforce the requirements of this regulation and all other applicable laws and regulations.

(1) The PMO will also investigate all alleged violations and submit to the proper authority for further action as required.

(2) The Camp Gruber Security Force will serve as the primary point of contact for federal, state, and local law enforcement agencies.

### **1-5. Notification System**

The CGMTC Commander will provide public information forty-eight (48) hours in advance regarding which training area(s) are open for hunting and fishing or other activities. Area availability notification will be provided using the following means:

(1) CGMTC Wildlife Management Web Page, <http://www.ok.ngb.army.mil/hunter/>

(2) Information will also be posted on the bulletin boards located at Hilltop Road and Highway 10 (Gate #12) and Gate # 38.

### **1-6. Fees**

It is the intent of the Commander not to charge for hunting or fishing access permits. Therefore, until additional funding is required to support the wildlife program, CGMTC access permits will be issued without charge.

### **1-7. Camping**

a. Camping on CGMTC is authorized only at Hunters Camp II and only during the designated hunting seasons listed in Chapter 2.

b. Public access to Hunters Camp II will be through Hilltop Road Gate (#12). This gate will open at 8:00 AM two (2) days before the start of the designated hunting season and will close at midnight on the last day of the designated hunting season.

### **1-8. Gates**

- a. The gates West of Highway 10 (5, 6, 43, 44, 45, 46, 48, & 49), Black Hollow Gate (16), gate 38, entering training area 103, and the two (2) gates (17 & 23) along Muskogee/Cherokee county line will be opened during the designated hunting seasons.
- b. Gates will be opened no later than 8:00 P.M. the day before the designated hunting season begins and will close at midnight on the last day of the designated hunting season.
- c. The Commander may open gates throughout the year at various locations to allow additional access. Gate closures and opening will be announced using the CGMTC Notification System. See map at the end of this regulation for gate locations.

### **1-9. Archeological or Historical Items**

- a. As required by the Archeological Resource Protection Act and AR 405-80, dtd 10 Oct 97 excavation or removal of archeological or historical items is prohibited without Federal or State approval specifically for that purpose.
- b. All users should report discovered archeological or historical items to the CGMTC Environmental Office, (918) 549-6223.
- c. Destruction of an archeological site and/or collection of antiquities, to include relics and arrowheads, are a violation of the Federal Antiquity Act and the Archeological Resource Protection Act and will be prosecuted accordingly.

## **Chapter 2 HUNTING AND FISHING**

### **2-1. General**

The opportunity to hunt and fish is a privilege extended by the CGMTC Commander and is subject to area availability, as determined by the Commander or his designated representative.

### **2-2. Access Permit**

- a. All hunters, regardless of age, wishing to hunt or fish on CGMTC must obtain an access permit and carry the permit at all times while on CGMTC property.
- b. Access permits will be issued for hunting, fishing or combination hunting/fishing, and trapping.
- c. To obtain an access permit individuals must provide the following documentation:
  - (1) Those hunters born on or after January 1, 1972 must have successfully completed a hunter education course.
  - (2) A valid hunting/fishing license or proof of exemption and appropriate stamps for the season being hunted as stated in the annual Hunting Guide published by ODWC.
  - (3) Annually view unexploded ordnance (UXO) brief.

### **2-3. Acquiring an Access Permit**

The following procedures pertain to all hunters and anglers desiring to gain an access permit to hunt or fish. Conditions and training requirements continually change, therefore all personnel using CGMTC must be aware of the current requirements or changes to ensure safety and provide the most enjoyable experience possible. To remain on the approved list, hunters and anglers must attend an orientation each year and receive a current access permit. A new roster will be generated each year to indicate who is eligible to hunt or fish on the CGMTC. Access permits will be issued on an annual basis and will be valid from 1 Jul thru 30 Jun.

a. Because some danger exists while hunting or fishing on CGMTC the following is required for all sportsmen.

- (1) Map orientation of CGMTC.
- (2) UXO recognition and procedures.
- (3) Overview of CGMTC activities.
- (4) Overview of CGMTC regulations and policies.

b. Access permits are issued at the Camp Gruber Range Control, Bldg 740 (918) 549-6042 or the OMD Security Station (918) 549-6021.

c. Orientations will be provided throughout the access permit year at the convenience of the CGMTC staff.

d. In past years, access permits have been issued on an individual walk-in basis. To assist hunters with scheduling, improve communications, and ensure the timely issuance of permits, Camp Gruber personnel in 2007 will begin offering scheduled briefings for large groups of hunters in addition to the walk-in option. Location for the group briefings shall be at Camp Gruber Building 108, with dates and times to be determined. Notification of briefing dates and times shall be made through the hunter notification system (see Sec. 1-5) and local media outlets, as funds allow.

### **2-4. Youth Access Permits**

- a. All individuals will be required to complete a safety/orientation briefing, including those less than 16 years of age.
- b. Youth less than 16 years of age must be accompanied by an adult at all times.

### **2-5. Armed Forces Personnel on Temporary Duty**

a. Military personnel performing temporary duty at CGMTC who do not reside in Oklahoma and desire to hunt, trap, or fish, must obtain the appropriate ODWC license.

b. Citizens of Oklahoma on authorized leave from the U.S. Armed forces and those serving outside Oklahoma are exempt from the hunting and fishing license requirement, however individual(s) must purchase applicable tags, permits, or stamps. Personnel on leave must have a valid ID card and verification of leave status in their possession.



## 2-6. Hunting Areas

- a. There are six (6) available hunting areas on CGMTC. Availability depends on the military training schedule.
- b. All sportsmen using CGMTC must recognize that hunting areas may be closed due to the military training mission of CGMTC. The Camp Gruber Range Officer and the Wildlife Manager determine area availability and post the schedule via the CGMTC Notification System.
- c. It is the individual's responsibility to ensure he/she is using an open area. All individuals must carry their CGMTC access permit on their person while afield.
- d. Hunting outside of an open area is illegal.
- e. Tagging and checking of game: Statewide regulations apply. See ODWC Hunting Guide for further information.
- f. Any person found hunting in an unauthorized area will be considered a trespasser, escorted off CGMTC, and subject to prosecution.

## 2-7. Designated Seasons

- a. All established hunting areas will be open during the following seasons.

(1) The nine (9) day primitive deer season beginning in October for deer hunting only.

(2) The first nine (9) days of deer gun season beginning in November for deer hunting only.

(3) The last twenty-one (21) days of December (11-31 Dec) for all wildlife activities.

(4) Nine (9) days during the spring turkey hunt beginning the second Saturday of April for turkey hunting only.

(5) Area access at all other times will be determined by the military training schedule. This includes access for the youth turkey hunt, youth antlerless hunt, youth antlerless deer gun hunt, and antlerless muzzleloader season. CGMTC is closed to the special doe gun season occurring in December and January.

- b. At no time is entry into the restricted area, as indicated on the enclosed map and marked in the field with "No Hunting" signs authorized. Individuals desiring entry to retrieve injured game, lost dogs, etc. must first contact Range Control (918-549-6041) or Camp Gruber Security (918-549-6021) to request an escort.

## 2-8. Bag Limits

Currently, bag limits for all Camp Gruber game species follow those set by ODWC for the Cherokee Public Hunting Area (PHA). See ODWC Hunting Guide for further information. Camp Gruber is closed to antlerless deer gun hunting, except for the special youth antlerless hunt. Check the CGMTC notification system for area availability.

## 2-9. Scouting

After obtaining a CGMTC access permit, individuals may scout hunting areas prior to and during any designated season. Individuals must check the CGMTC Notification System to ensure the area is open for use. No firearms may be in the vehicle or in the individual's possession while scouting, except under provisions of the Oklahoma Self Defense Act.

## 2-10. Dogs

a. All training of dogs is prohibited from June 1 through Aug. 31 annually. Additionally, the training of dogs is prohibited during the designated hunting seasons cited in section 2-7 above. Training of dogs is limited by hunting area availability.

b. No person may train or have in possession more than three (3) dogs outside a regular harvest season.

c. Individuals participating in dog training must first obtain a CGMTC access permit and comply with all policies in this regulation and the ODWC Hunting Guide.

d. No captive live species may be released or used for training and no game shall be taken.

e. No person while in pursuit of game with hunting dogs outside the regular harvest season shall possess the means to harvest game.

f. Retrieving Lost Dogs.

(1) The CGMTC permits hunters to retrieve lost hunting dogs; however, entry into restricted areas is prohibited, unless escorted by CGMTC personnel. Contact Range Control (918-549-6041) or OMD Security (918-549-6021) to request escort into the restricted area.

(2) Hunters pursuing lost dogs are not permitted to transport or carry weapons. Hunters retrieving lost dogs must check in and out at Range Control.

(3) Failure to comply with these instructions will be sufficient cause for revocation of access privileges.

## 2-11. Off road Travel and All Terrain and Utility Vehicles

a. All motorized vehicles must stay on the maintained trail and road network.

b. No all terrain vehicles (ATV) or utility vehicles (UTV) are allowed on CGMTC for recreational purposes; however those access permit holders who have acquired the ODWC Nonambulatory Permit will be authorized to use an ATV or UTV. All personnel operating an ATV are required to wear a safety helmet.

c. Individual who possess a valid ODWC Motor Vehicle/Nonambulatory Permit are restricted to established roads and trails.

## 2-12. Hunting After Sunset

a. Statewide restrictions apply. See ODWC Hunting Guide for further information.

b. The use of horses and mules is authorized while in pursuit of furbearers at night during the last 21 days of December (11-31 Dec) only.

### **2-13. Trapping**

- a. Statewide restrictions apply. See ODWC Hunting Guide for further information.
- b. Trapping will be only permitted the last 21 days of December (11-31 Dec).

### **2-14. Fishing**

- a. The use of trotline, bank poles, snagging, or jug fishing in any pond on Camp Gruber is prohibited.
- b. Boat Equipment & Special Restrictions.
  - (1) All watercraft must be properly licensed in accordance with state law and regulations.
  - (2) Boat motors allowed on Camp Gruber shall not exceed 15 hp; except at Greenleaf Lake where there is no horsepower restriction.
  - (3) All boats must have proper safety equipment as required by law.

### **2-15. Ponds**

- a. Generally, all ponds will be available for fishing in accordance with the hunting area in which they are located. Periodically, ponds will be closed to fishing for various management practices and training requirements.
- b. Fishermen must check to ensure availability through the CGMTC Notification System.
- b. A valid Oklahoma Fishing License and CGMTC Access Permit are required.
- c. Size and Creel Limits. Statewide ODWC regulations apply.

### **2-16. Disabled Hunters and Anglers**

Statewide restrictions apply. See ODWC Hunting Guide for further information.

## **Chapter 3 SAFETY**

### **3-1. General**

There shall be strict compliance with all safety rules and regulations.

### **3-2. Blaze Orange**

All Sportsmen must comply with statewide regulations concerning when and how to wear blaze orange. See ODWC Hunting Guide for further details.

### **3-3. Speed Limits**

- a. Unless otherwise posted, the speed limit is 25 MPH on all dirt roads and trails.
- b. It is unlawful to park privately owned vehicle(s) in a manner that block gates and roads or in a way that obstruct vehicular traffic.

### **3-4. Roads and Barriers**

- a. The CGMTC road network is equipped with a protective barrier system. Gates, cables, or both are provided for safety and to protect sensitive areas from vehicular damage.

- b. Roads and trails that enter or cross the impact areas remain closed to all traffic and are not to be used for any purpose except by authorized traffic.
- c. Road gates, barricades, and cables shall not be moved or by-passed by unauthorized personnel. Such action may result in revocation of CGMTC access privileges.
- d. Gaining access or attempting to gain access through any means other than established roads and trails is prohibited.
- e. Unauthorized off road travel is prohibited.

### **3-5. Restricted Areas**

- a. Restricted areas may not be entered at any time without escort by CGMTC Personnel.
- b. Restricted areas include the cantonment, weapon firing ranges, and areas where unexploded munitions are possible. These areas are closed to the general public.
- c. All hunting, fishing, and other recreational activities are strictly prohibited in the restricted areas unless specifically authorized in writing by the CGMTC Commander or designee.
- d. Anyone entering a restricted area without authority/escort will be subject to arrest for trespassing and will have their CGMTC Access Permit permanently suspended.
- e. The enclosed map details boundaries of the restricted area. In the field, the restricted area is posted with "No Hunting" signs.

### **3-6. Unexploded Ordnance (UXO)/Duds**

- a. If you encounter what you believe is UXO, mark the point so it can be easily located from an access road and report the find to Range Control (918-549-6041) or OMD Security (918-549-6021).
- b. Under no circumstances shall any UXO/Dud or suspected objects be touched or moved.

### **3-7. Use of Alcohol and Drugs**

It is unlawful to hunt/fish while under the influence of intoxicants on CGMTC or to display or consume alcoholic beverages in public or use/possess narcotic drugs.

### **3-8. Fires**

- a. Report all uncontrolled fires to Range Control (918-549-6041) or the OMD Security (918-549-6021).
- b. Open fires will only be allowed at Hunter's Camp II in an enclosed fire ring.
- c. During dry conditions, as identified by the CGMTC Commander, or if CGMTC is under a state fire ban, no fires will be allowed.

### **3-9. Firearms**

- a. It is unlawful to fire any type of firearm inside Hunter's Camp 2.
- b. Firearms are not permitted in any CGMTC facility. All other firearms/weapons are prohibited and subject to confiscation. The individual in possession of the firearm is subject to prosecution.
- c. Specification for firearms and bows: Statewide restrictions apply. See ODWC Hunting Guide for further information.
- d. Possession of a firearm in an open hunting area is permitted only when used for hunting purposes in the designated seasons, except under provisions of the Oklahoma Self Defense Act.
- e. Transportation of Firearms. All firearms must be completely unloaded, to include empty chambers, magazine wells or have magazine clips detached, when being transported or stored in any moving or stationary vehicle, except under provisions of the Oklahoma Self Defense Act.
  - (1) Firing a firearm from a vehicle is strictly prohibited.
  - (2) For the purpose of transportation in a vehicle, muzzleloaders are considered "unloaded" when all gunpowder has been removed from the flash-pan or the percussion cap has been removed from the nipple.

## **Chapter 4 SUSPENSION AND REVOCATION OF ACCESS PERMIT**

### **4-1. General**

Access to CGMTC is subject to these administrative suspension/revocation procedures and military training requirements. Each CGMTC guest has the responsibility to ensuring that no illegal or unsportsmanlike conduct occurs within their hunting/fishing party. Personnel may lose CGMTC access privileges if they are convicted of a hunting/fishing violation or commit an unsafe act.

### **4-2. Authority**

- a. The Training Site Manager through the CGMTC Security Force and Provost Marshal's Office enforces suspensions and revocation of hunting and fishing privileges in accordance with provisions of this regulation.
- b. Game Wardens and other appropriate officials will notify the Security Force of any cited violations occurring on CGMTC and provide copies of appropriate documentation.

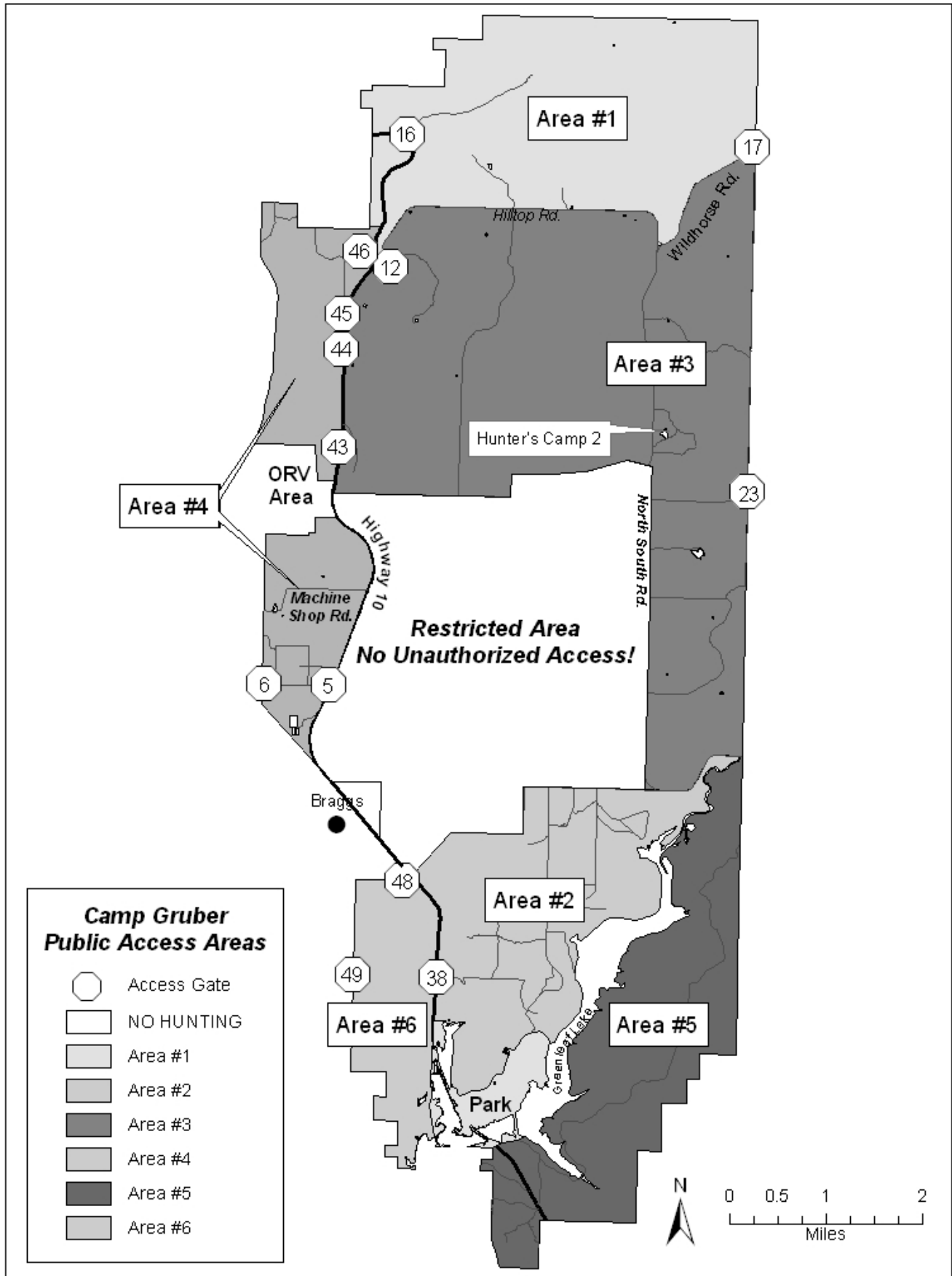
### **4-3. Administrative Procedures for Suspension and Revocation**

- a. The Wildlife Manager will provide written notice of pending charges and actions and provide an administrative hearing, if requested by the accused in

writing. The purpose of the administrative hearing is to review any evidence against the cited individual(s), listen to and review any evidence or testimonies and determine if the proposed suspension or revocation is warranted. Suspension or revocation will become effective 10 days after written notice is issued unless the affected person before the expiration of the 10 day period makes a written application for a hearing. Such application will stay the proposed suspension or revocation for a period of 10 days from the receipt of the application.

- (1) If a hearing is not held within 10 days of the receipt of the application for hearing, the suspension will not take place until such time as the person is granted a hearing and is notified of the action of the Wildlife Manager. However, if the affected person requests a hearing be continued to a date more than 10 days after the receipt of the application, the access permit will be temporarily suspended until the Wildlife Manager resolves the charges. Such resolution shall include whether these regulations were in fact violated and, if so, whether further suspension of privileges is appropriate.
  - (2) If it is determined, as a result of the hearing, to suspend or revoke the affected person's CGMTC access privileges, the decision will specify when the suspension or revocation is effective.
- b. The Wildlife Manager will be the reviewing authority and shall conduct administrative hearings. During administrative hearings:
    - (1) The reviewing authority will examine any statements, testimony, or other evidence presented by CGMTC authorities and the access permit holder.
    - (2) All testimony will be recorded.
    - (3) The reviewing authority will render a written decision within 10 days of the hearing, concerning the validity of the suspension or revocation to the Training Site Manager for signature.
  - c. Individuals who desire an administrative hearing to review a charged violation may submit request in writing to the Training Site Manager, Camp Gruber Maneuver Training Center, PO Box 29, Braggs, OK, 74423.
  - d. The Training Site Manager is the final authority on all suspensions, revocations, extensions or the reduction thereof.
