Total points earned for retired pay. Prior to 23 Sep 1996 the maximum IDT points (IDT, MEM & ACCP) a soldier could receive credit for is 60. Between 23 Sep 1996 and 30 Oct 2000 the maximum was 75. Between 30 Oct 2000 and 29 Oct 2007 the maximum was 90. After 30 Oct 2007 the maximum was 130. Soldier must have 50 points
