6. Once you have dragged your file onto the site, click "Drop-Off Files".

7. The AGR Management team will provide notification that your application has been received.

If AMRDEC SAFE is not allowing you to drop packet, try clearing SSL Certificates, close browser, and try to submit again in Chrome or Edge. Do not try to submit via Internet Explorer.

\_\_\_\_2.Certified Board Selection ERB/ORB. Must include applicable MOS or AOC and ASVAB Scores.

<u>3. Individual Medical Readiness Record with DD 2766C.</u> Must include current Periodic Health Assessment date, PULHES, and DD 2766C (Vaccine Administration Record) with COVID Completion Series. PHA must be current within 12 months. Human Immunodeficiency Virus (HIV) must be current within 24 months.

\_\_\_\_\_4. DA Form 3349 Physical Profile (If Applicable). No temporary profiles are accepted except pertaining to pregnancy.

**\_\_\_\_\_5. OKNG Form 113 (Sep 2015) (Commanders Certification of Current Weight)** certifying current height and weight (dated within the last 30 days), (with DA Form 5500-R/5501-R if required), with body fat computations completed before closing date of this announcement). Must be certified by the <u>Soldier's Commander or Full Time BN</u> <u>AO</u>. If other than the commander or AO signs, delegation of signature authority memorandum from the commander is required. <u>All</u> forms must be digitally signed.

## 6. DA 5500/ DA 5501 (If Applicable)

7. DA Form 705 reflecting last 4 APFT (Aug 2021) Last 4 APFT for record. <u>All signatures/initials on the DA</u> Form 705 must be digital signatures. After 1 April 2024, the DA Form 705 requirements will reflect the change to the Army Combat Physical Test (ACFT) and APFT information will no longer be accepted. <u>May use last APFT on</u> record prior to 1 April 2024.
