2. All applicants must meet ACFT (Army Directive 2022-05) and HT/WT standards
3. Must not be under a current suspension of favorable personnel actions or required to be under suspension under AR 600-8-2, even if no suspension has been imposed.
4. All applicants must be able to complete all required training, Comprehensive Medical Training (two weeks) and the Common Faculty Development-Instructor Course (two weeks), within 12 months of being selected.
5. All applicants must be able to teach at least one Comprehensive Medical Training course during each Training Year (TY).
6. All applicants must be comfortable speaking in front of large groups
